

TJ Teenagers Win National 99er Pairs

Stephen Drodge of McLean, VA and Andrew Rodriguez of Annandale, VA, who are both seniors at the Thomas Jefferson High School for Science and Technology in Alexandria, Virginia, posted two strong sessions in the Boston Fall NABC's National 99er Pairs event to comfortably win the contest, which is restricted to players with fewer than 100 masterpoints. The classmates scored 66.29 percent in the morning game and followed up with a 61.74 percent in the afternoon. "We learned bridge because there was nothing to do on the bus," quipped Drodge, who taught himself to play from reading about the game in books and on the Internet. He then introduced the game to Rodriguez.

"I taught him to play during class instead of paying attention."

It is the first NABC for either player; they have been playing together for a year and a half.

In second place were Sandra Naber of Victoria, BC and her son John Naber, who is a student at MIT.

President's Message

The New Year is underway and I hope that you all enjoy a happy, healthy and prosperous 2009. Without a doubt 2008 presented us with one of the most turbulent and challenging financial crises that this nation and the world has ever experienced. Despite the terrible losses in the stock market and many financial institutions, or perhaps because of them, folks kept playing bridge. Whatever the reason, the NVBA attendance at Sectionals and Unit games remained very strong.

While not quite prosperous, the NVBA fiscal year has four months remaining and indications are that this year we will most likely break even, and possibly come out on the positive side of the ledger. The NVBA Board and the Finance Committee of Alan Breed, Herb Fallin and Jennifer Nisenoff worked long and hard to scrub the Unit expenditures to produce a budget that strives to yield a small surplus by year's end. As we near the end of the fiscal year, 30 April 2009, the Board will re-check the numbers and set a budget in place for 2009-2010 that continues the flow of black ink. The Treasurer is a key player in the Unit finances, and beginning in September 2008, Livingston Johnson volunteered to be the Unit Treasurer, replacing Dale Dallaire, who stepped down.

In my last column I spoke of a possible re-vitalization of the NVBA Round Robin, similar to the one that exists in the WBL. For a variety of reasons, this Round Robin did not gather enough support and momentum to become a reality. Maybe next year?

I had a chance to enjoy a few days at the Boston Fall NABC. The crowds seemed enthusiastic at the tables and the various events. Look for some of the highlights featuring local players elsewhere in this newsletter. I am especially pleased to note that Stephen Drodge and Andrew Rodriquez won the National 99er pairs in Boston! Stephen and Andrew are students at Thomas Jefferson High School (TJ), and the NVBA has been an active supporter of the TJ Bridge Club for many years. Suzanne Abrams is the current Bridge Advisor to TJ, and Nancy Cartwright is her principal assistant and cookie buyer. Congratulations to Stephen and Andrew!!

The continued success of the NVBA depends upon the hard work and excellent support of its professional Directors and many volunteers. There are many activities that can always use additional volunteer support, and one of them is operating the duplicating machine for the Unit Game and Sectionals. Gene Schuyler has fulfilled this responsibility for many months, but occasionally finds that his professional work responsibilities limit the time that he has available to duplicate boards for the Unit Sectionals. This is a task that occurs four times per year and requires the duplication of about 25 sets of boards. Each set takes about 20 minutes to duplicate, give or take a few minutes. The NVBA pays the machine operator \$9 per set to perform the duplication. The operation of the duplicating machine is relatively simple and quite reliable. If you are interested in

The Spring NABC was undersubscribed, presumably because no one wanted to go to Detroit. Las Vegas was over 19,000 tables but still a disappointment, presumably because gas was over \$4 a gallon and air fares were outrageous. Now gas is below \$2 a gallon (and air fares are still outrageous) but Boston took a beating. The final total was 10,636 tables, some 2,000 below estimate and folks were trying to figure out why. IN MEMORIAM

Samuel Westgate III

Retired diplomat, Samuel Shelton Westgate III, passed away Oct. 13, 2008, surrounded by family and friends.

Born in 1944 to Samuel Shelton Westgate Jr. and Lillian Lohn Westgate in Grafton, Dr. Westgate spent his childhood in Wyoming and Alaska, before returning to Bismarck in 1954. Debate team member, Boy's State representative and editor of the school newspaper, the Hi-Herald, Dr. Westgate was co-valedictorian, graduating summa cum laude with honors from Bismarck High School in 1962. After receiving a B.A. from Stanford University and a Ph.D. from U.C. Berkeley, Dr. Westgate taught at King Faisal University in Saudi Arabia. Sponsorship by North Dakota Senator Quentin Burdick brought Dr. Westgate to the State Department's U.S. Information Agency as a foreign service officer, serving 22 years in Thailand, Switzerland, Czechoslovakia, Ethiopia and Germany. Dr. Westgate spoke seven languages, was a member of Mensa with an IQ of 176 and was a Silver Master in Bridge.

Internationally renowned pianist, Don Wetzel, wrote, upon learning of the former Consul General's passing, "He was surely one of the most highly respected and beloved of U.S. Diplomats who had ever served in Southwest Germany."

Prior to retirement, upon returning to Washington, D.C., Dr. Westgate served as United States Acting Deputy Director for Public Affairs for the African Nations. His voice was heard over "Voice of America" lending to the outcry about Darfur.

Dr. Westgate is survived by his wife of 26 years, Pummarie Summondis Westgate; their sons, Guy and Geoff; and siblings, Leanne, Lorinda, Bill and Jenette. He was 64.

ANGELA (GALE) M. CLARKE (Age 87) of McLean, VA died Friday, October 24, 2008. She had complications from Alzheimer's disease. Her husband of 63 years, Col. Harry J. Clarke, died in 2007. Survivors include her children, T. Michael, Jeffrey, and Marilou Shotwell, five grandchildren, three great grandchildren, two sisters-in-law, and eleven nieces and nephews. Inurnment will be May 29, 2009, at Arlington National Cemetery. In lieu of flowers, donations may be made to the Alzheimers Association in her name.

Gale was born in Meadow Lands, PA, and moved to the Washington area in the early 1950s. She was a competitive bridge player here in the 1960s and 1970s, won the Women's Pairs at the North American Bridge Championships in Cleveland in 1969, and competed for the United States in international championships held in Sweden, Bermuda and the Canary Islands. She taught bridge in Fairfax County during the 1970s and became a senior instructor before she retired.

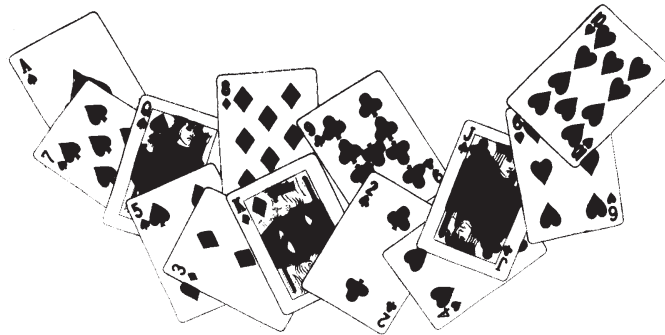

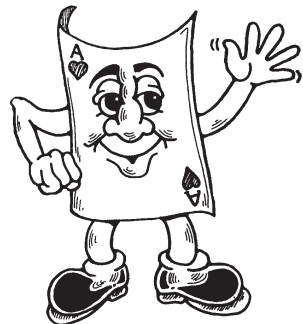

The 2009 District 6 GNT

It's time to get to your local club and qualify to win a partially subsidized trip to Washington, D.C. at the Summer 2009 NABC. You will represent District 6 in the national finals of this grassroots competition. The club qualification period began on September 1, 2008 and will continue until April 2, 2009. District level competition for the 0-5000 flight will begin in February (see chart below). This is a different time table than in previous GNT District qualifiers. Make sure you qualify early. You can go out and play as

often as you want with whomever you want. Once again, the competition will contain four flights at the District level. The Open flight is open to all players. Flight A is limited to players with 0-5000 masterpoints. Flight B is limited to players with 0-2000 masterpoints. Flight C is limited to Non-Life Masters with fewer than 500 masterpoints. Masterpoint eligibility is determined by the ACBL as of September 1, 2008. At the club level, the Open and A flights will be combined. Masterpoints awarded at the club level are half-red, so it's an easy way to earn red points without traveling or changing your local partners or playing habits. In the District level competition, the match awards are red and the overall awards are gold (Flight C awards 25 percent gold and 75 percent red).

Remember, players qualify as individuals at the club level and may form new teams with qualified players for the District phase of the competition. What this means is that you can play with all of your friends at the club level, no matter what your flight eligibility and then form one or more teams to compete in one or more flights at the District level. So, come out and play. Call your club manager to find out when the club is holding qualifying games. As club dates are made available to the District GNT coordinator or District webmaster, they will be posted on the District 6 website at www.districtsix.org.

We will be holding the first weekend of the District finals of Flights B and C at separate northern and southern sites. The southern sites will be Charlottesville, VA and Newport News, VA. Both will be on the same weekend. You must pre-register to play. Pre-registration ends midnight on the Thursday before each event begins. To pre-register, send \$96/team in a check made out to District 6, provide the names of all team members, the ACBL numbers for team members, and captain's e-mail address to Lynn Jones, 10 Tenby Court, Timonium, MD 21093.
