NVBA Annual Meeting and Awards

The Northern Virginia Bridge Association is planning to hold its annual meeting online via Zoom on Thursday, May 13, 2021. The NVBA Board has been surveying members to ensure that enough will attend online so that a quorum will be present to conduct the business of the meeting (75 members needed). Members will be sent a Zoom link to join the meeting via the email address on file with ACBL. The meeting will begin at 5:00 PM. The slate of Candidates for the new Board will be presented. Georgette Weiss is nominated for President, to replace Marty Bley, and Jay Simon is running for Vice-President. Current board member Georgia Booker has offered to serve as Secretary, and Ann Atcheson has once again agreed to be Treasurer. Board members George Parkins and Howard Stevens are stepping down.

At this time, there are three candidates to fill the three empty positions on the Board, so the vote will be by acclamation unless additional candidates present themselves. Brief biographies of the three candidates can be found on the next page, in alphabetical order. If you would like to run for the Board, please notify current President Marty Bley.

The Treasurer will report on the state of the Unit's finances, and the President will announce the Unit winners of the ACBL Mini-McKenney and Ace of Clubs awards (see page 8 for the top three finishers in each category in 2020). We also usually present the trophies for NVBA Man and Woman of the Year, the Rush Buckley Award (to the non-Life Master who won the most points in NVBA-sponsored events), and the NVBA Rookie of the Year. We do not have the data to compute the winners of these awards for 2020. If there is no other business, the meeting will adjourn, and players are welcome to play in the Unit Game that will follow the meeting.

Candidates for the NVBA Board

Jason Carter

Jason is an Associate Director in the Department of Justice's Office of International Affairs (OIA), in DOJ's Criminal Division, managing transnational cooperation in criminal matters involving Europe and Eurasia. From 2007 to 2010, Jason served as the Department of Justice Attaché to the United Kingdom, where he was based at the U.S. Embassy in London. Jason also has participated in the negotiation of bilateral treaties and multilateral conventions related to mutual legal assistance and extradition, and has headed numerous bilateral meetings with foreign counterparts. Jason has been a Special Assistant U.S. Attorney in the District of Columbia. He received his bachelor's degree from Columbia University and his juris doctorate from New York University School of Law.



Of relevance to the Northern Virginia Bridge Association, Jason has served as a member of the District of Columbia's Board on Professional Responsibility, appointed by the District of Columbia Court of Appeals and ultimately serving as Vice Chair of the Board. He also has served as a member of the Board's rules committee and as a hearing committee member and chairperson in the DC attorney disciplinary system. He is a member of a committee serving the Council of the Alfred Street Baptist Church. He is a professional umpire with the Northern Virginia Baseball Umpires' Association and is training to become a bridge director.

When Jason was a teenager, he learned to play bid whist, a game akin to bridge, with his family. He went on to learn to play bridge in his late 20s, and played it sporadically for about one year, earning fewer than five masterpoints. Like many of us, while working, he then didn't play for about 20 years. Several years ago, he discovered the Northern Virginia Bridge Association, where he was warmly welcomed by former Board member Francesca Mazarella. Through bridge, he rekindled a family relationship with a cousin (Georgia), augmented a friendship (Mike), and made new, good friends (Jamie, Deborah, John, Ben, and others). He achieved the rank of ACBL Life Master at the end of 2020, partnering with Jamie Dahlberg. He looks forward to helping his fellow bridge players enjoy the game as a member of the Board.

Jamie Dahlberg

Jamie Dahlberg has almost 40 years of experience as a corporate tax attorney, including eight years with the IRS serving in a variety of capacities. He also spent seven years with a large Washington law firm and has been a professor at the Georgetown University Law Center, the University of San Diego School of Law and the George Mason University Graduate School of Business Administration. Jamie recently retired as a Deloitte Principal after leading the Corporate Tax Group for over 15 years, and currently acts as a consultant to Deloitte. Jamie attended Cornell University (BA 1978), Boston College Law School (JD 1981), and Georgetown University Law Center (LLM (Tax) 1984).

Jamie is an avid Nats and Caps fan (when they play) and is the

3. Log into the system with your ACBL Number and password – press 'Log In'. If this is your first time on the ACBL site, click on 'Register for MyACBL' and follow the instructions on that page to register.
4. To change your email or mailing address, click on the BLUE 'Update My Information' box, then click on 'Update My Contact Information', enter/change your mailing and/or email address and click 'Submit'.
5. Then, click Privacy Settings on the left side of the page and after 'Confidentiality' change the entry to 'Share' and click 'Update'.

As a matter of policy, we will not release any of your information to anyone, and we will only use it to provide you with the weekly newsletter and important information about Unit activities and events. About three years ago, we stopped printing and mailing out copies, and started just posting them on the NVBA website, where they can be downloaded and printed.

Recently on various bridge Facebook pages there has been much discussion about returning to play in tournaments. To run tournaments requires volunteers. To do that contact the Tournament Chair and offer your services. If you volunteered once, volunteer again and work more than one day. Additionally, you need to understand that tournaments MAY very well NOT be what they were previously. The biggest roadblock we are finding, as we try and book them for the 2022 year, is that hotel chains have taken EVERY possible event they can get their hands on, most of them being for the weekends. Therefore you might find that a tournament you used to attend that ran from Monday to Sunday is now only available from Monday to Thursday or Tuesday to Friday. We expect it will take a year for things to get back to normal in terms of scheduling, and even then the tournaments may NOT be what they were previously.

If you don't go to tournaments any longer, then you could consider volunteering at your local club or unit game. Ask the director if you can be of service in any way. He/She may or may not have a job for you, but asking costs you nothing and helping will make both of you happy.

I hope this finds you well. If you haven't received your vaccine, I hope you will get it soon. Ross and I got our second dose on March 16, and so by the time you read this we should be good to go!

The cookbook was sold at \$20.00/copy and the proceeds donated to a local community charity, ECHO. NVBA covered the printing costs so that all the proceeds could go directly to the charity.

She believes this continued partnership with ECHO helps this Northern Virginia community see its way through these difficult times, and gives us an opportunity to come together as a bridge community and do something good. (Francesca is being recognized for her efforts by being named to the national ACBL Goodwill Committee.)

The ECHO volunteers are our peers in age and spirit. The Executive Director, Anita King, was happy to receive \$3,090 raised from the sale of cookbooks, as well as bridge books donated by Elizabeth Huffman and a matching donation from Prudential. Other checks came in later for a total of \$3150. ECHO volunteers also bought cookbooks and the project was put on their website as an example of creative ways to fund raise.

At Christmas time, Carolyn Baird and Francesca went Christmas shopping online and took advantage of the sales at Macy's to buy the cutest little girl outfits as well as winter puffer coats for girls and for boys up to sizes 18-20. The giving feeling spread and Joanne Mazarella and Lucy McCoy bought new clothes and laundry detergents to donate.

The list will include items of food and clothing and household supplies that will be posted as needed. To make your donation even more effective, after placing an item in your cart go to [Amazon Smile](#) and complete your purchase there. If you designate ECHO as your selected charitable organization a portion of the cost of your purchase will be donated to ECHO by Amazon. Remember to use Amazon Smile regularly whenever you shop and ECHO, as your designated charity, will receive a donation from Amazon every time you make a purchase. Thanks for shopping for us!
